European Yoga Alliance is a voluntary alliance of diverse Yoga organizations and teachers dedicated to upholding the integrity of Yoga, maintaining voluntary national standards for Yoga teachers and providing support for Yoga professionals in Europe. European Yoga Alliance is making every effort to inform the public of the Registry. Yoga Alliance will also provide networking and support for all Yoga teachers, registered or not, Europe. resident or not. European Yoga Alliance invites your participation and comments.
